



**MISSOURI WOMEN'S GOLF ASSOCIATION
FIFTIETH JUNIOR AMATEUR CHAMPIONSHIP
RAYMORE, MO
JUNE 9 – 10, 2010**



ELIGIBILITY

1. Must reside in the State of Missouri or Johnson County, Kansas, for at least 60 days prior to the first day of tournament.
2. Junior Age Limit: All girls through 17 years of age. Also eligible, 18 year old high school senior girls graduating in the summer, up to September 1, following their senior year in high school.
3. Entries are subject to rejection at any time by the MWGA. The reason for rejection may include lack of attendance at the Mandatory Rules Seminar, unbecoming conduct or improper dress.
4. All contestants must adhere to the Amateur Code as specified by the USGA.

ENTRIES/WITHDRAWALS

1. **ENTRY DEADLINE: Tuesday June 1, 2010**
2. Each entry application and fee must reach the MWGA Junior Director, Nancy Sebastian, by the entry deadline. Post mark will be used, if necessary, to determine late entries.
3. All entries are subject to approval by the Board of Directors of the Missouri Women's Golf Association and the host Club/Course.
4. Entries shall be returned if not accompanied by an entry fee and a correctly completed entry.
5. The entry fee will be refunded, less a \$10 administrative fee, if withdrawal occurs prior to the entry deadline stated above, or if the field is full on the first day of play. If the field is not full, there will be no refund for a withdrawal.

TOURNAMENT FORMAT

1. A thirty-six (36) hole, stroke play competition. The two day low total will determine the Junior Champion. There will be a winner and a runner-up in all age groups.
2. Age groups will be determined by birth date as of June 10, 2010. Any girl playing for the Championship Title must play from the Championship tees. (Apx. 6000 yards) Age groups may be flighted if a sufficient number of entries are received and will be determined after the first day scores.
3. Course Set Up by Flights:

13 years of age & Under	-	18 Holes Front Tees
14-15 years of age	-	18 Holes Championship Tees
16-18 years of age	-	18 Holes Championship Tees
4. Play is governed by the Rules of Golf as adopted by the USGA, and where applicable, by the Local Rules and consistent with those Rules.
5. **DRESS CODE: Contestants may wear skorts, tailored slacks or bermuda shorts. Tight or short shorts/skorts, tight slacks and/or tank/tank-like tops or cropped shirts (above the waist) are prohibited. All blue denim apparel is prohibited. PARENTS AND SPECTATORS must wear a shirt with a collar, no athletic attire (sweat suits, gym shorts), no denim pants or shorts. This dress code is in compliance with Creekmoor Golf Club's Board of Directors Policies and will be strictly enforced by the golf staff and MWGA.**
6. Contestants must walk; contestants are not permitted to have a caddie.
7. In the event of inclement weather and the course is deemed unplayable USGA Rule 33-2d is in effect as well as the procedure in discontinuing and resuming play. Rule 6-8.

PRACTICE ROUND

1. Tuesday June 8 - Practice Round Contestants Only - other golfers not permitted. (One practice round per contestant allowed.)
2. Practice rounds are encouraged prior to June 8. For practice round tee times, call Creekmoor Golf Club at 816-331-2621 and identify yourself as a MWGA Junior Amateur Championship participant. The practice round greens fee is \$ 20.
3. Please remember Creekmoor insists parents/spectators be dressed in shirts with a collar. No athletic attire or denim allowed. The staff and committee, as required by the Board of Directors, must strictly enforce this dress code.
