Entry has to be received by the Entry/Pairings Director by September 8<sup>th</sup>.

Each entry application and fee must reach the MWGA Entry/Pairings Director by the entry deadline. Incomplete entries will be returned. All entries are subject to approval by the Board of Directors of the Missouri Women's Golf Association and the host Club/Course.

#### ELIGIBILITY

1. Must be an individual member in good standing of the Association.
2. Must reside in the State of Missouri or Johnson County, Kansas, for at least 60 days prior to the first day of tournament.
3. Must have an established USGA Handicap Index.
4. Must adhere to the Amateur Code as specified by the USGA.
5. Entries are subject to rejection at any time by the MWGA. The reason for rejection may include unbecoming conduct or improper dress.
6. Accepted teams will be posted on the MWGA Website ([mowomensga.org](http://mowomensga.org)) on September 10<sup>th</sup> OR email notifications will be sent out IF an email address is included on the entry form.

#### ENTRIES/WITHDRAWALS

1. Entries shall be returned if not accompanied by an entry fee and a correctly completed entry.
2. **The field shall be determined from the first 60 teams consisting of two contestants per team.** In case of a tie for the 60<sup>th</sup> spot, the accepted team will be chosen by blind draw. Entries exceeding the limit will be placed on a waiting list in order of receipt.
3. Entry fees will be refunded, less a \$10.00 administrative fee, if withdrawal occurs prior to the entry deadline stated above, or if the field is full on the first day of play. If the field is not full, there will be no refund for a withdrawal made after Entry Deadline.
4. All entrants are expected to complete tournament play. If one withdraws for a reason deemed unacceptable by the Tournament Committee, she shall be ineligible to play in Association competitions for the following year.

#### TOURNAMENT FORMAT

1. A thirty-six (36) hole scramble competition. On the first day of play, the field will be split based on the low handicap of the team. The number of entries will determine flights (maximum 5). On the second day of play, teams will be flighted according to first round scores. Ties for Championship flight will be decided by a sudden death playoff; all other ties will be decided according to the USGA Rules of Golf, Appendix 1, Part C, Section 11, Stroke Play, (c), paragraph-1 (last nine holes will be 10-18).
2. At the completion of the final round, a team that improves their score more than the allotted strokes, determined at the completion of the tournament by blind draw, will be moved up to a higher flight.
3. Play is governed by the Rules of Golf as adopted by the USGA, and where applicable, by Local Rules consistent with those Rules.
4. DRESS CODE: Denim is never allowed on the premises. Contestants may wear skirts, slacks or shorts. Tight or short shorts/skirts, tight slacks are prohibited. Tank like tops or cropped shirts (above the waist) are prohibited. If the shirt is sleeveless, it must have a collar. If sleeved, a collar is not required. This dress code will be strictly enforced.
5. AUTOMOTIVE TRANSPORTATION: All contestants must ride. Cart fees are included in the entry fee.

#### PUBLICITY, PROMOTION and BROADCASTING

The MWGA may arrange for promotion of this Championship for radio, television, broadcasting and other exhibition and publication of this Championship, including the MWGA Website. By this application, the player consents to the use by the MWGA, or persons authorized by the MWGA, of her name, likeness, voice and references to her and photographs and other images of her and her play connected with her appearance in this Championship or any portion(s) thereof, in connection with such media promotion, broadcasting and other exhibition and publication of this Championship.

Bag storage will be available.  
Practice round can be played the Tuesday - Thursday the week before the tournament.  
There will be a special on Tuesday's that players may ask for: Golf-N-Food for \$45, from 7 AM to 3 PM.
