ELIGIBILITY

1. Be an individual member in good standing of the Association.
2. Must reside in the State of Missouri or Johnson County, Kansas, for at least 60 days prior to the first day of tournament.
3. Must have an established USGA Handicap Index (Hcp/I).
4. A SENIOR shall be one who has reached the age of 50 on or before the first day of the tournament.
5. Entries are subject to rejection at any time by the MWGA. The reason for rejection may include unbecoming conduct or improper dress.
6. All contestants must adhere to The Rules of Amateur Status as specified by the USGA.

ENTRIES/WITHDRAWALS

1. ENTRY DEADLINE: Friday, April 23, 2010. ENTRIES RECEIVED BEFORE MARCH 15, 2010 WILL NOT BE ACCEPTED.
2. Each entry application with all applicable fees must reach the MWGA Entry/Pairings Director by the Entry Deadline date.
3. Entries shall be returned if not accompanied by all applicable fees and a correctly completed entry form, including mandatory Hcp/I information.
4. The field shall be determined from the 120 entrants with the lowest Hcp/I. Entries exceeding the limit will be placed on a waiting list in order by Hcp/I.
5. All entries are subject to approval by the Board of Directors of the Missouri Women's Golf Association and Jefferson City Country Club.
6. Entry fees will be refunded, less a \$10.00 administrative fee, if withdrawal occurs prior to the entry deadline stated above, or if the field is full on the first day of play. If the field is not full, there will be no refund for a withdrawal made after Entry Deadline date.
7. All entrants are expected to complete tournament play. If one withdraws for a reason deemed unacceptable by the Tournament Committee, she shall be ineligible to play in Association competitions for the following year.

TOURNAMENT FORMAT

1. This is a thirty-six (36) hole, stroke play competition. A contestant may compete for the title of MWGA Senior Champion and play the Championship Division course (5200 to 5400 yards) OR forfeit the right to compete for the title of MWGA Senior Champion and play the Open Division course (5000 to 5100 yards). A contestant **MUST** indicate on her entry form whether she will compete in the Championship or Open Division. A contestant may not change her chosen Division once her entry is sent. The two day low gross score will determine the Senior Champion. The two day low net score will determine the Senior Low Net Winner. Ties for Senior Champion and Low Net Winner will be determined by a sudden death playoff beginning on a hole to be determined by the Committee; all other ties will be decided according to the USGA Rules of Golf, Appendix 1, Part C, Section 11, Stroke Play (c), paragraph-1 (last nine holes will be 10-18).
2. Play is governed by The Rules of Golf as approved by the USGA, and where applicable, by the Local Rules consistent with USGA Rules.

TOURNAMENT INFORMATION

1. AWARDS: The number of flights in each Division will be determined by number of contestants in that Division.
2. DRESS CODE: Soft Spikes only. Denim is never allowed on the premises. Contestants may wear skorts, slacks or shorts. Tight or short shorts/skorts or tight slacks are prohibited. Tank-like tops or cropped shirts (above the waist) are prohibited. If the shirt is sleeveless, it must have a collar; if sleeved, a collar is not required. **This dress code will be strictly enforced.**
3. Contestants must ride. A contestant is NOT allowed to have a caddie.

FEES

Practice round and bag storage are both optional.

If you chose either option, payment must be included with your completed entry form.
